The Ramona Town Board met Tues. Jan 13, 2026, at 6:00 pm in the Ramona Community Building with members Tony Fischer, Lisa Beyer, and Robert Sechser present.

Meeting was called to order. Previous meeting minutes were read. Motion by Beyer, seconded by Fischer to approve as read.

Reading of Resolution 106-26, authorizing the bar to be open on Sunday, Feb 8, 2026. Motion by Fischer, seconded by Sechser to adopt Resolution 106-26. All voted aye, motion carried.
